






Premises and facilities

The school will make the performing arts theater, classrooms or private meeting rooms available for discussions between the provider and students, as appropriate to the activity. The school will also make available AV and other specialist equipment to support provider presentations. This will all be discussed and agreed in advance of the visit with the Careers Leader or a member of their team. Providers are



welcome to leave a copy of their prospectus or other relevant course literature to be distributed by the Careers Coordinator as appropriate, and copies will remain available to all pupils from the Careers office.

Aspiring Futures is the career service provider from Wigan Council. A Careers Adviser from Aspiring Futures is in school on Monday and Tuesday. Pupils are able to access information, advice and guidance via an appointment. There is also information available to pupils in the Library.
